


The 374 documents selected for this volume many of them not previously publicly available — illuminate the context, implementation, and development of Australian policies towards the South Pacific island of Nauru from 1945 to 1962. Two further volumes on the relationship addressing the critical period from 1962 to 1968, when Nauru attained independence — will be published in 2024–25.

While administering Nauru under a League of Nations' mandate (from 1920) and then under a UN trusteeship (from 1947), Australia's primary interest was accessing Nauru's phosphate and providing it to Australian — and New Zealand — farmers at a very favourable price. The British Phosphate Commissioners (BPC) and their staff managed this extraction on behalf of Australia and its partners, New Zealand and the United Kingdom, with the heavy work done by Chinese and other imported labourers. Phosphate extraction was interrupted in 1942, when Japanese troops took over the island. Later, as the tide of war turned, Australian ministers lobbied strenuously but unsuccessfully for US support for the early recapture of Nauru.

After Japan's surrender, the three partner governments, through the BPC, ensured the prompt replacement of war-damaged infrastructure so that extraction and export could resume.

Australia's post-war External Affairs Minister, H. V. Evatt, took a leading part in establishing the UN Trusteeship system as an improved, more progressive version of the League's mandate system and in securing trusteeships over Nauru and New Guinea. As under the mandate, Australia shared its authority over Nauru with New Zealand and the United Kingdom. Australia diligently fulfilled its administering obligations and mostly received a sympathetic hearing from the UN Trusteeship Council in the late 1940s and 1950s. From around 1960, however, UN support for the rapid decolonisation of the remaining Western colonial territories strengthened, forcing Australia to modify its approach.




## FALSE PROFITS OF ETHICAL CAPITAL

#### False profits of ethical capital is a thoughtprovoking approach to understanding stakeholder capitalism.

Rather than focusing on the inadequacies of corporate responsibility, sustainable investment and consumer politics, this book grapples with the technical and rhetorical functions of ethical capital for profit and accumulation. It provides a unique and eclectic analysis of the political dynamics between finance, capital and labour, offering a refreshing perspective on struggles interlocking social, ecological and economic crises, and suggesting new ways of thinking about sustainability politics.



**EMPIRE RELIGIOSITY** Convent habits in colonial and postcolonial India TIM ALLENDER

This book explores Roman Catholic female missionaries and their placement in colonial and postcolonial India. It offers fascinating insights into their idiomatic activism, juxtaposed with a contrarian Protestant raj and with their own church patriarchies.

During the Great Revolt of 1857, these women religious hid in church steeples. They were forced into the medical care of sexually diseased women in Lock Hospitals. They followed the Jesuits to experimental tribal village domains and catered for elites in the airy hilltop stations of the raj. Yet, they could not escape the eugenic and child rescue practices that were the flavour of the imperial day.

New geographies of race and gender were also created by their social and educational outreach. This allowed them to remain on the subcontinent after the tide went out on empire in 1947. Their religious bodies remained untouched by India yet their experience in the field built awareness of the complex semiotics and visual traces engaged by the East/West interchange. After 1947, their tropes of social outreach were shaped by their direct interaction with Indians. Many new women religious were now of the same race or carried a strongly anti-British Irish ancestry.

#### In the years after the First World War the British government had to adapt its communication policy to connect with the new mass electorate.





This book examines the government's own Film Units and their slow development of the Public Information Film. By reviewing the entire film catalogue produced by the Empire Marketing Board, the General Post Office and Crown Film Units, particular themes are identified which not only reflect the demands of the Units' sponsors but also the anxieties and concerns of the 1930s and 1940s. The impact of the films is explored through the contemporary reaction of the audiences to them. By the time the Crown Film Unit was closed in 1952 a style of Public Information Film had been developed and continued into the 1970s.

#### This study overturns twentiethcentury thinking about pasticcio opera.

This radical way of creating opera formed a counterweight, even a relief, to the trenchant masculinity of literate culture in the

seventeenth century. It undermined the narrowing of nationalism in the eighteenth century, and was an act of gross sacrilege against the cult of Romantic genius in the nineteenth century. In the twentieth century, it found itself on the wrong side of copyright law. However, in the twenty-first century it is enjoying a tentative revival.

This book redefines pasticcio as a method rather than a genre of opera and aligns it with other art forms which also created their works from pre-existing parts, including sculpture.






traditional genre and as a way of working.
