

#### This book explores Greek Australian literature through its paramythic tropes and focuses on reading it as a bridge between multiculturalism and world literature.

The poems, novels and novellas that draw from paramythic forms and tropes draw from its symbolic power and its performative function, and often use it subversively to speak the unspeakable. They often merge incommensurate forms and include foreign words and registers or dialects, which lead to the need for translation, as well as the possibilities for what Apter calls the 'untranslatable'.


Foreign words and strange customs as well as oral storytelling forms may be untranslatable to outsiders — but their usefulness is tied to what Apter refers to as a 'linguistic form of creative failure with homeopathic uses'. So, when the paramythic voice, forms and tropes are located, translated, compared and interpreted in works by Australian writers having a Greek heritage, we have a new way to read Australian literature.

While sculpture remained central to his artistic practice, Isamu Noguchi's (1904-1988) interests and production spanned an exceptionally broad terrain that included furniture and lamps, stage sets for dance, plazas, courtyards and gardens.



Noguchi made no distinction between design, craft, and the so-called fine arts: in his view all of these could all be considered art should their aesthetic qualities sufficiently transcend those generated by the simple address of need.

Although his gardens include several of the twentieth century's most iconic landscape designs and have received almost universal praise, Noguchi nonetheless occupies a place removed from the normal practice of landscape architecture.

In our inability to understand precisely what happened between the two is the genius of their imitation of Sterne.



It is true in any case that his thought laid the groundwork for many theoretical and empirical social studies.
