




### **LET THE DEAD SPEAK** Spiritualism in Australia ANDREW SINGLETON, MATT TOMLINSON

This book explores the historical and social dynamics of Spiritualism – a religious movement associated in the popular imagination with nineteenth-century parlour séances and ghost photography. It continues to be practised actively today in Australia, the UK, and USA.

The authors draw on their deep fieldwork, interviews, and archival research to analyse Spiritualism's resilience and the enduring popular appeal of mediumship.

There are three key contributions of the book: the first is that the scholarly study of 'belief' should be rehabilitated. The authors propose a model of belief as a dialogue between claims to truth and commitments to institutions supporting those claims. The second is women's agency in Spiritualism. From the movement's beginnings, strong female leaders have decisively shaped its religious and political profile. The third is the need to analyse Australian Spiritualism as a distinct variant of a transnational Anglophone family of ritual practice.



### CHALLENGING NUCLEARISM

A humanitarian approach to reshape the global nuclear order MARIANNE HANSON

# *Challenging nuclearism* explores how a deliberate 'normalisation' of nuclear weapons has been constructed, why it has prevailed in international politics for over seventy years and why it is only now being questioned seriously.

The book identifies how certain practices have enabled a small group of states to hold vast arsenals of these weapons of mass destruction and how the close control over nuclear decisions by a select group has meant that the humanitarian consequences of nuclear weapons have been disregarded for decades.

The recent UN Treaty on the Prohibition of Nuclear Weapons will not bring about quick disarmament. It has been decried by the nuclear weapon states. But by rejecting nuclearism and providing a clear denunciation of nuclear weapons, it will challenge nuclear states in a way that has until now not been possible. *Challenging nuclearism* analyses the origins and repercussions of this pivotal moment in nuclear politics.



### **IMPLEMENTING A GLOBAL HEALTH PROGRAMME** Smallpox and Nepal

### Worldwide eradication of the devastating viral disease of smallpox was devised as a distant global policy, but success depended on implementing a global vaccination programme within nation states.

How this was achieved remains relevant and topical for responding to today's global communicable disease challenges. The small and poor Himalayan kingdom of Nepal faced enormous geographical and infrastructure challenges if it was going to succeed in a nationwide vaccination programme.

This book acknowledges the key role of the WHO but disrupts the top-down, centre-led standard narrative. Against a background of widespread internal political and social change, Nepal's programme was expanded, effectively decentralised and a vaccination strategy introduced that aligned with people's beliefs. Few foreign personnel were involved.





His representative motifs are characterised – above and beyond the formal concept – by intensive exploration into the reality of the living world and a high level of poetic abstraction.



A scholarly, modern-spelling edition of a play by the Caroline dramatist John Ford, which has not seen much previous critical attention due to being accidentally omitted from the 1652 edition of his complete works.





The introduction resituates the play in the Ford canon and explores how it spoke to audiences when it was first composed in the late 1620s, when it tapped into the contemporary fascination with the pathology of melancholy, and also when it was finally published in 1653. By this time the play's main plot about a sovereign who is threatened with execution would have recalled the beheading of Charles I four years earlier. The play can thus be seen as examining both psychology and politics.





Ellis's critical introduction analyses new data that uncovers the play's authorship, playing company, and playhouse for the first time, as well as exploring the occasion of the play, its textual and theatrical histories, and its stagecraft.



In 1835, the Manchester Natural History Society opened the doors of
