

#### Bringing together knowledge from terrestrial and aquatic systems, *Quantifying Diets of Wildlife and Fish* explores traditional approaches to studying animal diets as well as newer methods such as chemical tracers and eDNA techniques.

Quantifying Diets of Wildlife and Fish presents different techniques available to study animal diets. Ecologists determine animal diets to build natural history knowledge, test hypotheses in ecological theory and make informed management decisions for important ecosystems. Many researchers use techniques traditionally applied to the animals they study, rather than techniques with the greatest potential for the aims of each project. In an effort to encourage researchers to consider new approaches, this book focuses on the techniques, rather than on particular groups of organisms or specific environments.

With contributions from leading ecologists, chapters explore experimental design, observational techniques (including new technologies), stomach contents and faecal analysis, eDNA, tracers and stable isotopes. They also cover the latest multivariate methods of analyses suitable for describing animal diets and feeding relationships, as well as testing hypotheses relevant to ecological theory, environmental management and biological conservation. The expert knowledge provided will encourage readers to look beyond the boundaries of their specialties, assist in testing important hypotheses and provide insights into management problems. The examples in this book cover a range of vertebrates and invertebrates, as well as different environments, to open these methods up for novice ecologists and stimulate lateral thinking in more experienced researchers.





#### This scholarly biography traces the life and art of Lebanese-American neo-expressionist, Nabil Kanso (1940-2019).





It explores key moments across the artist's transnational career by foregrounding his longest-

running, internationally toured exhibition, the Journey of Art for Peace (1985-1993). More specifically, it traces the historical trajectory of his  $10' \times 28'$  mural-scale painting, Lebanon, from the circumstances of its production at the height of the Lebanese Civil War in 1983, through its short-lived exhibition history with the *Split of Life* series in the few years that followed.

The book scaffolds an understanding of the artist as an activist and works toward offering distinctly spatial readings of his painterly practice.

## JULIUS BISSIER UND RICHARD BAMPI

#### In the 1950s, a large number of internationally renowned artists created pictures made of ceramic.

In 1956, in close collaboration with the artist and ceramicist Richard Bampi, Julius Bissier developed a ceramic work for the University

of Freiburg. The abstract composition on a wall in the city centre measures over 19.5 metres long by 2.6 metres high (64 x 8.5 feet). Its restoration and relaunch is occasion to examine more closely the story of its genesis. The distinctiveness of the artwork becomes clear against a backdrop of the cultural politics oriented on France in Freiburg after 1945. Unexpected parallels in contemporaneous ceramic murals are revealed and make the Freiburg ceramic picture a unique work in the post-war art of Germany. Text in German.

This book shows how the artist became the favourite of sophisticated patrons, who were eager to decorate their residences with pagan Greco-Roman mythological subjects. Piero's vividly imagined portrayals led to his cornering the market on these commissions. At the same time his more orthodox, but never ordinary, religious altarpieces and private devotional paintings also won the admiration of leading Florentine families.
