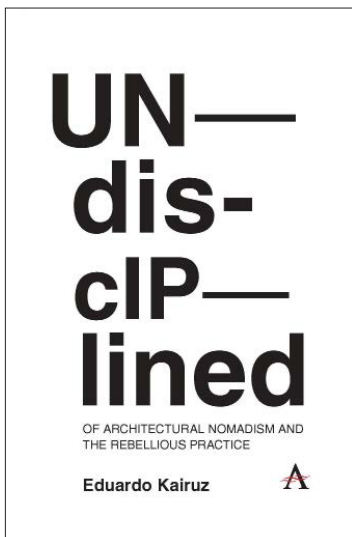


About the author:

Anthony T. Hughes has taught in the School of Law at the University of New South Wales since 2004 and previously taught in its School of History for over a decade. He is also Adjunct Professor at Boston University Sydney Internship Program and has taught at the University of Western Sydney and the University of New England. He has lectured at universities in Canada, China, the Kingdom of Thailand, Switzerland and the Republic of Ireland. He has written widely on social, cultural and legal issues. Dr Hughes was Executive Officer of the UNSW Centre for Olympic Studies from 1996 to 2004. He is a visiting professor at the Humanistic Centre for Olympic Studies at Renmin University, Beijing and Honorary Consultant at the Art Research Centre for the Olympic Games at the Central Academy of Fine Arts, Beijing. In 2005 he was awarded the UNSW Vice Chancellor's Award for Teaching Excellence.

He is the co-author of *Essays in Sport and the Law*, *The Game for the Game Itself: A History of Sydney Suburban Rugby* and *The Pavilion on The Village Green: A History of Sport at UNSW*.

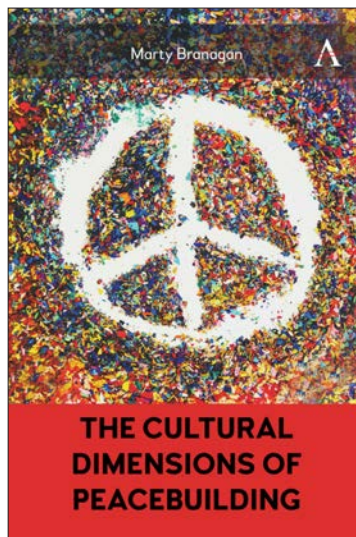
Hughes is an Honorary Life Member of UNSW FC, where he played for 14 years. He was awarded a Blue in 1982.

This broad-ranging book examines the creation, through the arts and culture, of societies that enjoy sustainable, positive peace.

It begins with a critique of the pervasive nature of militarism and violence embedded deep in the cultural fabric of many societies, influencing the language and discourses we use, the films we watch, our museums and histories, our journalism, and our education systems. It also examines the roots of violence in our parenting styles, gender roles, and spiritual practices. It contrasts this with an examination of a number of peaceful societies that already exist, drawing useful lessons from their cultures. It critiques discrepancies in history education with regard to war and peace and examines artistic and cultural processes, institutions, and artifacts designed to create peace, such as peace museums and parks, peace journalism, peace education, and resistance to violence through cultural means, such as film-making, fine arts, satirical theatre, and protest music. Solutions-oriented, it examines the efficacy of these attempts and suggests positive ways forward. It also explores the role of gender in creating cultures of peace and the impacts on peacebuilding of cultivating peace within.

Punk went its own way, and 'Bad Painting' set the agenda in paintings.

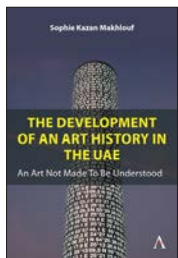

In late-eighteenth and early nineteenth-century British literature, Scandinavia emerged as a place where Gothic terror took place.

This book explores the extensive use of Nordic superstition in providing a vocabulary for Gothic texts as well as the cultural significance it had for writers attempting to understand Britain's northern roots. In Gothic publications, Nordic superstition sometimes parallels the representations of Catholicism, allowing writers to gloat at its phantasms and delusions. Thus, the casting of runes, runic spells and incantations, and necromantic communications could replace practices usually assigned to Catholic superstition. On terms of its cultural importance, however, Nordic lore did more than just fill in for hackneyed Gothic formulas. It is a key argument in the book that Nordic superstition presented less of an abject 'Other'.
