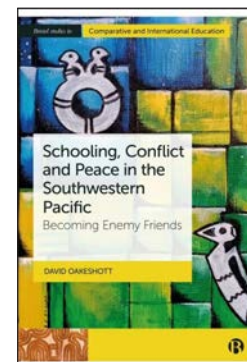


## SCHOOLING, CONFLICT AND PEACE IN THE SOUTHWESTERN PACIFIC

In doing so, it suggests a critical understanding of sectarianism, subjectivity and memory politics in the province, and argues for the importance of placing punk within the segregated structures of everyday life described by the interviewees.

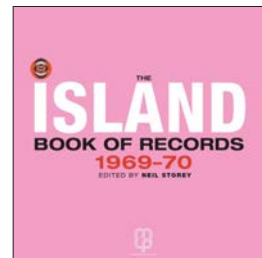

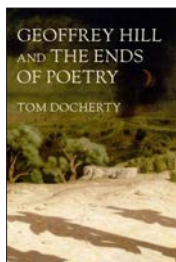
**GEOFFREY HILL AND THE ENDS OF POETRY**

**The idea of the end is an essential motivic force in the poetry of Geoffrey Hill (1932-2016).**

This book shows that Hill's poems are characteristically 'end-directed'. They tend towards consummations of all kinds: from the marriages of meanings in puns, or of words in repeating figures and rhymes, to syntactical and formal finalities. The recognition of failure to reach such ends provides its own impetus to Hill's poetry.

This is the first book on Hill to take account of his last works. It is a significant contribution to the study of Hill's poems, offering a new thematic reading of his entire body of work. By using Hill's work as an example, the book also touches on questions of poetry's ultimate value: what are its ends and where does it wish to end up?

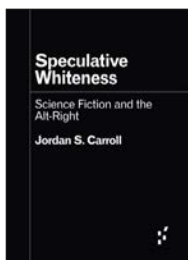
**SPECULATIVE WHITENESS**

Fascists such as Richard Spencer interpret science fiction films and literature as saying only white men have the imagination required to invent a high-tech future. Other white nationalists envision racist utopias filled with Aryan supermen and all-white space colonies. *Speculative Whiteness* traces these ideas through the entangled histories of science fiction culture and white supremacist politics, showing that debates about representation in science fiction films and literature are struggles over who has the right to imagine and inhabit the future. Although fascists insist that tomorrow belongs to them, they have always been and will continue to be contested by antifascist fans willing to fight for the future.



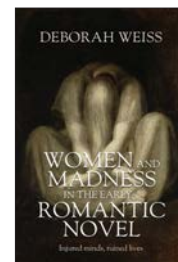

**From the workings of financial markets to our response to the ecological crisis, economic theory shapes the world. But where do these ideas come from?**

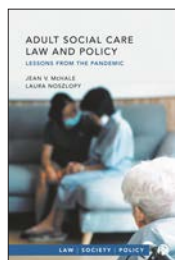
*Ricardo's Dream* tells the fascinating story of David Ricardo, Adam Smith's only real rival as the ‘founder of economics’: The wealthiest stock trader of his day, Ricardo introduced the study of abstract models to economics. He also developed the theory of trade that underpinned globalisation and hides, behind its mathematical façade, a history of power, empire and slavery.
