

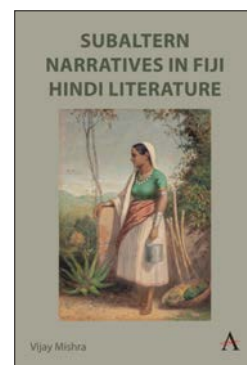
SUBALTERN NARRATIVES IN FIJI HINDI LITERATURE

***Subaltern Narratives in Fiji Hindi Literature* is the first comprehensive study of fiction written in Fiji Hindi.**

Its target texts are two extraordinary novels *aukā Purān* 'A Subaltern Tale' (2001) and *Fiji Maa* 'Mother of a Thousand' (2018) by the Fiji Indian writer Subramani. They are massive novels (respectively 500 and 1,000 pages long) written in the *devanāgarī* (Sanskrit) script. They are examples of subaltern writing that do not exist, as a legitimization of the subaltern voice, anywhere else in the world. The novels constitute the silent underside of world literature, whose canon they silently challenge. For postcolonial, diaspora and subaltern scholars they are defining (indeed definitive) texts without which their theories remain incomplete. Theories require mastery of primary texts and these subaltern novels, 'heroic' compositions as they are in the vernacular, offer a challenge to the theorist.

THE KINGS OF ALGIERS

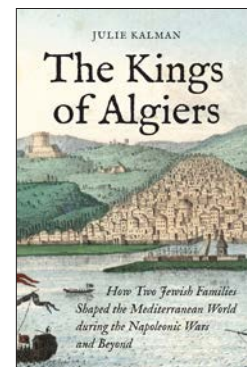
How Two Jewish Families Shaped the Mediterranean World during the Napoleonic Wars and Beyond

A richly detailed history of the Bacris and the Busnachs, two renowned Jewish families whose influence and reputation shook the capitals of Europe and America.

At the height of the Napoleonic Wars, the Bacri brothers and their nephew, Naphtali Busnach, were perhaps the most notorious Jews in the Mediterranean. Based in the strategic port of Algiers, their interconnected families traded in raw goods and luxury items, brokered diplomatic relations with the Ottomans, and lent vital capital to warring nations. For the French, British and Americans, who competed fiercely for access to trade and influence in the region, there was no getting around the Bacris and the Busnachs. *The Kings of Algiers* traces the rise and fall of these two trading families over four tumultuous decades in the nineteenth century.

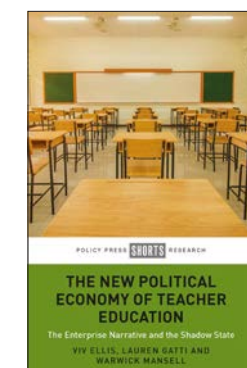

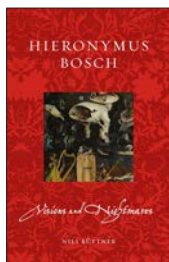

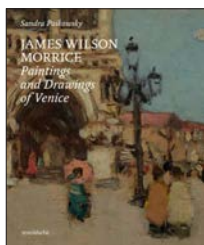

Living in Paris for most of his life, Morrice (1865-1924) was the first Canadian painter to make regular trips to Venice from the mid 1890s to about 1908. This book situates Morrice within the history of Venice and Venetian art in the late 19th and early 20th centuries by looking carefully at his more than 100 modernist paintings and numerous drawings of 'La Serenissima'. During his lifetime, Morrice's Venetian pictures appeared in art exhibitions in Paris, London and other European countries, as well as in Montreal and the United States.

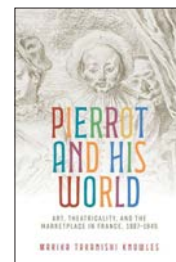

This richly illustrated book offers an account of Pierrot's recurrence in painting, printmaking, photography and film, tracing this distinctive type from the art of Antoine Watteau to the cinema of Occupied France. As a visual type, Pierrot thrives at the intersection of theatrical and marketplace practices. From Watteau's *Pierrot* (c. 1720) and Édouard Manet's *The Old Musician* (1862) to Nadar and Adrien Tournachon's *Pierrot the Photographer* (1855) and the landmark film *Children of Paradise* (1945), Pierrot has given artists a medium through which to explore the marketplace as a form for both social life and creative practice.

When we imagine life behind the high walls of the fortress-like prisons that were built and modified as the modern prison system was created in the mid-nineteenth century, we conjure up scenes where strict regulation prevailed to control people in body and in mind.

An image that poses something of a paradox is that of mothers and their babies living in this carceral environment. This book looks behind the cell doors of these institutions to illuminate the experiences of this group of prisoners. The management of their health alongside the management of penal discipline posed complex conundrums to the prison system. Although rarely fully considered at policy level, this balancing act was negotiated by those who lived and worked in prisons on a daily basis.
